

## **Festival News**

E estival 2016 is now in full swing, with six festivals completed last term, 40 booked for this term and almost the same number already booked for the third term. Entry forms have been emailed or posted to schools having Festivals next term so please check with me if you have not received yours.

A number of schools are finding the new online forms convenient and easy to work with. However, if you prefer to print, fill them in manually and return copies to me, you may do so.

If you have not yet booked a Festival for this term, please contact me immediately for a date in June

At a recent meeting of adjudicators some observations were made regarding presentations in the following categories which we would like you to take note of.

- ♦ PowerPoint Presentation the candidate should avoid reading directly off the screen.
- ♦ The suggested minimum number of candidates in a Choral Verse is eight. Two children saying a poem together cannot be adjudicated as a Choral Verse.
- ♦ Experimental Interpretation is a category that allows a candidate to enter an item that does not fit in anywhere else in the syllabus. It MUST include some spoken word, e.g. an introduction or explanation of the item to be presented.

Although Festival Convenors receive a letter with the entry forms that guide one through the admin process, the table below might also be helpful.

4.	Submit completed entry forms to S & D Association by due date.	SCHOOL - Festival Convenor	
5.	Post report pads, confirmation letter & Clerk's letter to school. Confirm details with adjudicator.	SADA - Festival Director	
6.	Pass Clerk's letter on to the person who will be assisting the adjudicator	SCHOOL - Festival Convenor	
7.	Prepare report sheets with candidates' names.	SCHOOL - Clerk/Convenor	
8.	Enjoy the Festival!	ALL	
9.	Tally up number of certificates required and inform SADA office. Return duplicate copies of reports.	SCHOOL - Clerk/Convenor and Adjudicator	
10.	Post certificates to school.	SADA - Festival Director

#### 2016 FEE SCHEDULE

Annual membership fee - R385 per school

Individual items - R20 per item

Group items - R70 per item

Group items with less than four in a group - R20 per person

Accommodation/travel levy - R700 per day per adjudicator (where applicable)

Workshop fee - R500 per hour
